Steps to Take After a Public Liability Incident

If you are injured in a public place, you may be entitled to compensation. Public places include shopping centers, parking lots, restaurants, sidewalks, parks, businesses, offices, and private homes. Here are four steps to protect your rights to compensation.

Seek Medical Treatment

Ensure that you promptly seek medical treatment, even if you think it's a minor injury. Be thorough in describing your injuries, symptoms and pain to your treating practitioner.

2 Describe the Incident

Document the circumstances of the injury

As soon as you are aware of an injury, whether it happens quickly or over a period of time, it is important to collate all the information you have about the cause of the injury. Look to see what has caused you the injury.

Take photographs, save emails and make file notes or diary entries. You should also consider who witnessed the injury occurring and record their details, in case they need to be contacted at a later date.

Report the incident

As soon as it is safe to do so, report the accident to the person, business or council that is responsible for the public place. If the other party has a formal way to report an injury, including completing an incident report, you should follow that process. Use short and simple sentences to explain what happened.
